1. PURPOSE OF THE AGREEMENT

The purpose of this agreement is to outline the terms and conditions under which the Consultant will provide services to assist the Student in the university application process for Canadian and European universities.

2. SERVICES PROVIDED BY THE CONSULTANT

The Consultant agrees to provide the following services:

- 2.1. Assessment of the Student's academic and personal needs.

- 2.4. Guidance on preparation for standardized tests required for admission.
- 2.5. Submission of applications to selected universities.

2.6. Follow-up after application submission (university responses, integration advice, etc.).

3. OBLIGATIONS OF THE STUDENT

The Student agrees to:

- 3.1. Provide accurate and complete information to the Consultant.
- 3.2. Adhere to deadlines for document submission.
- 3.3. Pay the agreed-upon fees for the services rendered by the Consultant.
- 3.4. Comply with the universities' admission requirements.

4. FEES AND PAYMENTS
